The City of Los Angeles Local Enforcement Agency (LEA) will be holding an informational meeting on the date and time shown below concerning the issuance of a revision to the solid waste facility permit (SWFP) for the Athens Services Sun Valley Material Recovery Facility (MRF) & Transfer Station at 11121 Pendleton St, Sun Valley, California, 91352.

On September 3, 2014, the Athens Services Sun Valley MRF & TS facility was issued a SWFP to operate a large volume transfer/processing facility. Currently, the facility is permitted to accept 1,500 tons of municipal solid waste per day and to accept waste from 7:00am-8:00pm, 7 days a week, and 24-hour processing.

On March 25, 2022, Athens Services submitted an application package to revise the SWFP to change the operational time from 7:00am-8:00pm to 5:00am-8:00pm for transfer activities. Included in the application was a proposed Transfer Processing Report (TPR) which provides operating procedures for the facility as well as important facility and contact information. The permit revision will also make the SWFP consistent with the plan approval that was granted by the City Planning Department in 2021. On June 15, 2022, the LEA reviewed the application package and determined that it is complete and correct pursuant to Section 21570 of Title 27 of the California Code of Regulations. Additional information on the application is available for public review on the LEA website or by appointment at the LEA address listed below.

The informational meeting is open to all interested parties to ask questions and provide comments regarding the Athens Services Sun Valley MRF & Transfer Station and the processing of the application package for the permit revision. Please send your comments in writing to the LEA either by mail or email. The LEA will review all comments received within a two-week period of the informational meeting and consider them for permitting purposes. All comments will be forwarded to the CalRecycle for their consideration.
